Cover Spotlight

A Record of Success

As one of California's go-to trial attorneys, Mary Alexander handles some of the state's most prominent litigation

Over her career as a trial lawyer, Mary Alexander has dedicated her practice to helping individuals injured by the negligent, preventable actions of others. Her work has obtained answers and accountability for victims with nowhere else to turn, and she continues to handle some of California's most high-profile cases.

Most recently, Alexander and her firm were appointed lead counsel for the plaintiffs in litigation stemming from a deadly warehouse fire that claimed the lives of 36 people in early December 2016. Alexander filed the first lawsuits in the case, and is now representing 10 families who lost loved ones in the blaze.

"This was the deadliest building fire in the United States in more than a decade, and it could easily have been prevented," Alexander says, "had it not been for the irresponsible actions and inactions of the building owner, the chief tenant, the people associated with the music event taking place that evening, and others."

On the night of the fire, the Oakland warehouse, known as Ghost Ship, was hosting a music event. As many as 100 people were in the building, and when the fire broke out, their escape was impeded by a lack of clear exits: the 10,000-square-foot, two-story building had been illegally converted into a maze of makeshift rooms and stairways.

"The warehouse didn't have smoke alarms, warning lights, exit signs, or fire sprinklers, and its configuration prevented those inside from getting out in time," Alexander explains. "To have this happen is gross negligence of the highest degree, and we are committed to seeing justice done for the victims' families."

Alexander has a history of significant recoveries, including a recent \$1.15 billion judgment in a public-nuisance lawsuit against



companies Sherwin-Williams, NL Industries, and ConAgra for promoting the use of lead-based paint in homes. Alexander served as co-lead counsel in the case, representing 10 cities and counties in California that sought the removal of lead-based paint from millions of homes.

Following this result, Alexander and the team were honored by the San Francisco Trial Lawyers Association and the Public Justice Foundation, with both organizations recognizing them as "Trial Lawyer of the Year." In reflecting on this success, Alexander, who has also been inducted into the California State Bar Litigation Section's Trial Lawyer Hall of Fame, credits her unique technical background.

"Prior to becoming a lawyer, I spent 10 years working in environmental and occupational health research, and I use that scientific knowledge every day in my practice," she says. "It ensures that my clients are well represented in these complex matters, whether the case involves the toxic effects of lead-based paint, fire cause and analysis, or any other public health issue."

In 2016, for example, after a four-week jury trial, the firm obtained an \$8 million verdict against baby product manufacturer Evenflo, with the jury determining that a standard Evenflo mattress had suffocated a 7-month-old baby. Initially, the cause of death was ruled sudden infant death syndrome, but the law firm proved that the death resulted from a mattress found in millions of homes across the country.

"This case highlighted a tragic and underreported problem in the United States—babies who suffocate from sleeping on mattresses that aren't air permeable," says attorney Joseph W. Carcione, Jr., who is now working to pass legislation ensuring that all baby mattress pads are breathable.

Among its other achievements, the firm prompted legislation outlawing baby walkers in California day care centers after obtaining a jury verdict that found a standard Century Products baby walker had caused the death of a one-year-old. In addition, the firm's \$296 million verdict against Ford Motor Company for a rollover accident influenced efforts to strengthen the roof support of vehicles. The jury in that case determined that the standard roof of the Ford Bronco was defectively designed and had killed three people and injured three others.

"We've worked hard to achieve the highest standard of excellence in representing our clients," says Carcione. "As a result, we've not only obtained many multimillion-dollar recoveries, but we've also helped to modify the behavior of powerful corporations and governmental entities."

Plaintiff's Personal Injury

Northern California's Top Settlements 2016

Rouda Feder Tietjen & McGuinn is a nationally renowned plaintiff's firm with a history of significant results in challenging personal injury cases. Indeed, the firm has recovered more than \$500 million for its clients since its founding in 1980. And 2016 proved no different, with the firm achieving a result that was recognized by Leaders in the Law as Northern California's top settlement of the year.

That result, a \$24 million recovery in a devastating auto accident, involved several complicated issues. But partner Timothy Tietjen was able to secure a settlement ensuring his client, the woman injured in the crash, would receive the necessary medical care. "Our mission as a firm is to help clients in these tragic cases improve their quality of life and find some light at the end of the tunnel," he says.

Tietjen's client, 27-year-old Rebecca Forkey, was driving north on Interstate 680 when she was forced off the road by the driver of an Acura SUV, who was himself swerving to avoid the impaired driver of a Toyota Highlander. Forkey suffered a permanent spinal cord injury in the rollover, among other injuries.

Although the Toyota driver had been on prescription drugs at the time of the accident, Forkey's main lawsuit was ultimately against the Acura driver—an employee of an Acura dealership who had reported the Toyota driver to 911 for erratic driving, but then

ignored the dispatcher's warning to stay away from the Toyota.

"Our initial obstacle was overcoming the police report determination that the fault of the accident was entirely that of the impaired driver, instead of the wannabe Good Samaritan," Tietjen says. "But the police conclusion was made without access to the 911 call logs, and by obtaining those we were able to show that it was the Acura employee who caused the accident."

With the Acura dealership as a central defendant in the case, Tietjen also faced a daunting independent-contractor defense (the argument that an employer is not liable for the torts of an independent contractor). Still, he rejected an initial \$17 million settlement offer, and eventually the case settled for \$24 million.

"It was a hard-fought case, but we wanted to ensure that Rebecca would be fairly compensated for her catastrophic injuries," Tietjen says. "And we're proud of the number of cases we've taken on like this, where we've served as a champion for our client's cause."


