## Girardi | Keese

Over fifty years ago, Tom Girardi opened the doors to his firm in downtown Los Angeles, determined to build a law firm where anyone who had been injured—whether physically or financially could obtain excellent counsel.

A few years later, Girardi proved the seriousness of his ambition, when he secured a \$1.4 million award (the highest medical malpractice verdict at the time in California) for an African-American teenager who was denied hospital care following an assault because the staff assumed he was drunk; the next morning, the teenager woke up paralyzed.

While Girardi started out focusing on automobile cases, he has expanded the firm's practice to include catastrophic injury cases, medical negligence, toxic tort, pharmaceutical cases, intellectual property matters, and class actions. "It's important to be forwardthinking in terms of what the next cause for concern will be—the new frontier of harm," Girardi notes. "Over the years we've transitioned into new territories as the world has changed around us." Today, Girardi | Keese is one of only a handful of plaintiffs' firms in the United States that handles cases involving pharmaceutical litigation, product liability, medical malpractice, class actions, intellectual property, antitrust, and business litigation. Indeed, the firm has successfully challenged auto manufacturers for unsafe product design and defective component parts. It has taken retailers and manufacturers to court for selling unsafe toys and children's products. And the firm's trial lawyers have regularly gone to court on behalf of people harmed by dangerous drugs or defective medical devices. Works litigation; \$633 million for residents of Hinkley, Calif., who were poisoned by PG&E; and \$545 million in a class action against Farmers Group and Zurich Financial Services.

The firm's most recent successes include an \$18 million verdict for Bryan Stow, a paramedic who was nearly beaten to death at the opening day of the Los Angeles Dodgers in 2011; and a \$765 million settlement for dozens of former pro football players suffering from memory loss and other ailments related to concussions. The firm has also represented thousands of individuals injured by defective pharmaceuticals and other medical devices, such as Yaz and Yasmin, Fosamax, and Transvaginal Mesh.

Among her many accomplishments as a plaintiff's lawyer, she oversaw the settlement of cases involving the recalled painkiller Vioxx, and also helped resolve cases for hundreds of individuals affected by the diet drug Fen-Phen.

# Legendary trial lawyer Tom Girardi and his firm, Girardi Keese, stand as strong advocates for the injured

Tom Girardi is widely regarded by his peers as one of the nation's top plaintiffs' lawyers, with more than five decades of experience in representing victims. From serving as the trial lawyer on the famous Erin Brockovich case to achieving notable victories against Vioxx, Merck, and the Los Angeles Dodgers, Girardi has time and again proven himself to be an expert litigator, as well as strong advocate for his clients during their toughest battles.

"It's an honor to be a lawyer because I'm able to help people when they are at their lowest," Girardi says. "That's what I've tried to do my whole life—many of the people we represent have been very severely harmed, and some will need medical care for the rest of their lives; so, fundamentally, our goal is to help them get the care and support they need, and ensure they are able to live to the fullest extent possible."

Growing up, Girardi knew from a young age that he wanted to be a lawyer. He remembers watching the television series Perry Mason, about an attorney who always won his case, and being fascinated by the character's powers of persuasion—even then, Girardi was certain he had found his calling. After being one of eight students selected to attend Loyola High School in Los Angeles, CA, Girardi attended Loyola Marymount University and then Loyola Law School. In 1965, he enrolled in a master's program at New York University to receive his LLM.

"The trial program at NYU was very inspirational," Girardi recalls. "All the giants of the New York legal profession would give talks at night; and when I returned to California, I was ready to take on the world and immediately start my own practice."

Initially, Girardi relied on friends who were a couple of years ahead of him to send him cases. But it wasn't long before Girardi started making his own headlines. Indeed, in 1970, Girardi became the first attorney in the state of California to win a one-million-dollar-plus award for a medical malpractice case. He has since litigated many major cases, including matters against Lockheed Corp, Los Angeles County Metropolitan Transportation Authority, Dole Food, Shell Chemical, and Hollywood's seven major movie studios.

The case that cemented Girardi's status as one of the nation's leading trial lawyers, though, was a toxic tort case against Pacific Gas & Electric utility company on behalf of 650 residents of the desert community of Hinkley, California. Members of the community were experiencing high incidents of cancer and other diseases, and the litigation argued that their illnesses were being caused by contaminated water leaking from the utility company's gas pumping station. The case resulted in a verdict of \$333 million.

"This was the case that was famously portrayed in the film 'Erin Brockovich," Girardi notes. "And the result, as well as the media attention it received, really helped to revolutionize the way people think about the chemicals they are being exposed to. So not only did the case do a lot of good for the Hinkley community, but it brought awareness to a growing problem."

Other notable cases Girardi has worked on include litigation against the pharmaceutical giant Merck in which he obtained a settlement of \$4.85 billion for consumers injured by the drug Vioxx, and a case against Ford Motor Company where he secured a \$45.5 million verdict for a 6-year-old child left paralyzed due to a defective seat belt. Girardi also represented Giants' baseball fan and paramedic Bryan Stow who was assaulted by two men in a parking lot at Dodger's Stadium following a game, leaving him brain damaged and disabled.

"There is a moral component to every one of our cases, and that's been true since the first day I started my law firm," says Girardi, whose firm has recovered more than \$11 billion in verdicts and settlements for its clients since its founding. "We are passionate about fighting on behalf of people who have been harmed, and the dedication of everyone at this firm has ultimately allowed us to become a world-class law firm that can stand as a strong advocate for those in need."
