SPBMC DELIVERS RESULTS FOR OUR CLIENTS

In 2018, the outstanding work of the attorneys at Sullivan Papain Block McGrath & Cannavo—showcased the firm's excellence and reaffirmed its long-standing reputation as a top tier personal injury firm. In the past year alone, SPBMC obtained several multi-million dollar verdicts and settlements on behalf of those who have been harmed as a result of the wrongdoing of others:

- •\$26 million medical malpractice negligence verdict on behalf of a client for past and future pain and suffering. The plaintiff, one of two twin girls born prematurely, was born with a host of life-long issues, including deafness and vocal cord paralysis. Her sister passed away within the month following the pre-term birth.
- •\$24 million settlement for a construction worker who was run over by a reverse-moving excavator resulting in the loss of one leg and multiple internal injuries.
- •\$9.97 million verdict in a medical malpractice case involving a doctor's failure to properly assess a patient for suicide risk and thus the failure to prevent suicide.
- •\$8.5 million settlement in a case involving hospital malpractice and negligence.
- •\$4.85 million settlement in a medical malpractice case involving the failure to diagnose a stroke.
- •\$4.55 million settlement for a delay in delivering an infant and for inadequate fetal monitoring strips.
- •\$4.5 million settlement in a case involving the failure to diagnose dengue fever, which resulted in death.
- •\$4.3 million settlement on behalf of a client for her pediatricians' failure to diagnose a condition of hydrocephalus.
- •\$4 million settlement on behalf of an electrical helper who was rendered

paraplegic due to a construction accident in which he came into contact with

•\$4 million medical malpractice negligence verdict on behalf of a client for emotional distress due to the loss of her five-month-old fetuses.

RECENT LONG ISLAND VERDICTS

In September, SPBMC achieved a \$19 million verdict against Nassau County for the County's negligent roadway design. Suit was brought by a motorcyclist who sustained severe injuries, including a below-the-knee amputation, when an oncoming vehicle made a left-hand turn into him. While it was the oncoming vehicle who crashed into the motorcycle, the jury found that a far greater degree of negligence was to be attributed to the County of Nassau for its failure to maintain a safe intersection. The case was tried by David Dean, a senior trial lawyer and partner at SPBMC.

Also in September, SPBMC obtained an \$8 million verdict in Suffolk County in a medical malpractice case. Suit was brought by a 35 year old man who suffered a leak of his vertical sleeve gastrectomy requiring multiple surgeries that prevented him from eating for about 8 months. The case was tried by Jim Wilkens.

We are additionally proud of the fact that Jim Wilkens secured the largest medical malpractice verdict in New York State in 2017- \$26,500,000.

These cases provide only a small sample of the tremendous, and ongoing, success achieved by the attorneys at SPBMC in 2018.

SEPTEMBER 11TH VICTIM COMPENSATION FUND (VCF)

Since 2002 SPBMC has been at the forefront in representing victims of the 9/11 terrorist attacks, having recovered more than \$1 Billion for its VCF clients.

In 2002, the firm played a key role in the establishment of the VCF, which served to help the families of those who died in the attacks, and those who became ill as a result of their exposure to toxins at Ground Zero.

In the original VCF, which closed in 2003, SPBMC recovered more than \$265 million for 363 injured firefighters and the families of deceased firefighters, all for no fee, earning the firm The National Law Journal's prestigious *Pro Bono* Award.

With many having been shut out of the first VCF because of the latent nature of their 9/11-related illnesses, the firm played a leading role in the re-opening of the VCF in 2011 under the James Zadroga 9/11 Health and Compensation Act, which provides both medical services and compensation to first responders, residents, office workers and others, who have developed 9/11-related illnesses as a result of their being in the Exposure Zone (Lower Manhattan below Canal Street) during rescue and recovery operations from 9/11 through May 2002.

Filing a claim requires the expertise of dedicated lawyers. "We have a deep understanding of the devastating impact that 9/11-related illnesses have had on first responders and those who lived and worked in the Exposure Zone," said SPBMC partner, Nicholas Papain. "We'll continue to fight for the interests of those who need and deserve help."

A Matter of Teamwork

Robert F. Danzi discusses his firm's successful track record and how he didn't earn his reputation for being 'the patient's advocate' entirely on his own.

When Robert F. Danzi reflects on his nearly 40 years in practice, the injury lawyer known as "the patient's advocate" immediately attributes his law firm's success to teamwork.

"Nobody can do it all alone," he says. "I started the firm as a solo practitioner, but always had a strong support system. I believe in hard work and attention to detail, which is why everyone in our office provides that same degree of dedication to our clients – because these are the times they need it most."

Indeed, victims and families impacted by medical malpractice, catastrophic injury and wrongful death continually turn to the Law Office of Robert F. Danzi when they need compassionate lawyers who can also be fighters in the courtroom or at the negotiating table. The firm is also led by partners Christine Coscia and John Danzi, and has secured hundreds of millions of dollars in verdicts and settlements throughout New York.

"When we accept a case, our clients benefit from the experience, knowledge and courtroom abilities of all three partners, as well as a dedicated staff," says Bob. "Our clients' goals become ours, and our individual skill sets and ability to communicate with each other has enabled us to secure victories and awards that might not otherwise be possible."

That dynamic was instrumental in 2018, when the firm represented the family of a child whose premature birth caused several severe conditions, including cerebral palsy and blindness. The firm settled against the hospital prior to the three-week trial in April, during which Bob and John argued that the mother's obstetrician's failure to counsel her on the use of progesterone during her pregnancy could have prevented the pre-term delivery. The jury agreed with the Danzis and awarded \$78 million for the plaintiff – one of New York's most substantial verdicts of the year and further solidifying the firm's reputation for commitment and client service.

"We met the plaintiff when she was 18-months-old and we instantly wanted to achieve justice on her behalf. She's now 10, and the damage done to her inspired our stamina in preparing for trial, which is why we always believed we could win," Bob says. "We were honored to fight for her and her family, who now have sufficient financial support for her care and treatment."

In recent years, the firm's precedent-setting verdicts and settlements have included:

B v. L - \$35 million – Catastrophic Injury

A 25-year-old man was brought to the hospital following a motor vehicle accident. Due to inappropriate postoperative administration of the wrong medication, the patient suffered a loss of oxygen to his brain, causing severe brain damage.

Dv. TR, MD et al. - \$7.321 million – Wrongful Death/Medical Malpractice A 46-year-old wife and mother of three minors visited the hospital with abdominal pain, requiring an appendectomy. Following the surgery, the surgeon unnecessarily removed the right half of her colon. The doctor failed to discover that he obstructed a major artery during the procedure, leading to her death.

R v. WCS, et al. - \$7 million – Catastrophic Injury/Motor Vehicle Accident In the aftermath of Hurricane Sandy, a pedestrian out for a morning walk was struck by an insurance adjuster's car, causing severe harm and injury.

"All our lawyers contribute to each case we handle, from depositions to trials," notes Bob. "The bond we share is extended to each client, who we treat like family. Our goal is to provide them with the best possible representation and, in doing so, hope that our work protects others from suffering similar tragedies."

Long Island Incident Tips

Long Island Incident Tips

Long Island is unique in that it has rural, urban and suburban areas – all of which can pose different personal and professional challenges, stemming the need for legal expertise. Your claim could be caused by anything from a negligent driver to a natural disaster or abusive workplace management.

Arming yourself with knowledge of what to do before contacting a lawyer is a smart strategy. This way, should a practitioner or firm accept your claim, you will help put them in an advantageous position. Below are some tips on what to do immediately following certain incidents.

Pedestrian Accident

If you were a pedestrian injured by any motor vehicle – or a driver who might have been unable to avoid the accident – do not assume that your case will be easy to prove. Pedestrians have an obligation to abide by all traffic laws and exercise reasonable care for their own safety. On the flip side, motorists also have a duty of care not to injure others. After calling the police or emergency services, try to have someone take pictures of the scene immediately and attempt to document:

- The exact location of impact.
- What traffic signals and lights may have been nearby, including the speed limit sign.

- The condition of the road and sidewalk.
- Other factors that may have influenced the impact, like weather.

Additionally, try not to engage in a dialogue with the other party. Even admitting that you weren't immediately injured may be used against you, should you have a delayed injury. Wait for the police to arrive to make any statements.

Weather Damage to Home and Property

Island particularly Long is susceptible to weather risks, having endured several hurricanes, tropical storms and blizzards - and even the shock of an earthquake in the last 10 years. No matter how much you prepare your home for extreme conditions, sometimes you just can't prevent feet of water from entering your house or a tree from falling on it.

Should you sustain damage due to any weather event:

- Contact your insurance agent.
 Determine whether your claim exceeds your deductible and whether you'll need estimates for repairs.
- Make temporary repairs to your house and take reasonable steps to protect from further damage.
- Keep your receipts for repair work and especially if you need to relocate.

• If you can't reach an agreement with your insurance company, you might contact a lawyer to represent you in your claim.

Wrongful Termination

From the moment you begin working for an employer - even if you accepted employment at will - you have rights and are protected from discrimination. bias and retaliation. Discrimination could qualify if you feel you've been fired due to race, nationality, religion, gender or age. Examples include someone being treated unfairly due to their ethnicity, or women who are fired due to Another pregnancy. example would be the employer's breach of contract, or firing you for refusing to do something illegal or against company or public policy.

In that case, speak to the human resources department. Though your employment has been terminated they will be able to answer questions for you about the termination process and what benefits you may be entitled to. Also ask if you are able to appeal the decision.

If you believe that you have been discriminated against or haven't been treated according to the law or company policy, you should consider hiring a lawyer, as you may be able to sue your former employer for wrongful termination.


